Construction Work of Phawa Khola Bridge	Bid Security Amount (NRs), 13,00,000.00 & Bid Fee (NRs) 5,000.00 (Non Re-fundable)

6. Bids must be valid for a period of 90 days after opening of bids and must be accompanied by Cash Security or Bank Guarantee, amounting as mentioned in table below, which shall be valid for 120 days after opening of the bids.
